Samskip Energy Adjustment Factor

25 June 2025

At Samskip, we believe that transparency is essential for building trust and maintaining a strong partnership with you. That’s why we wish to inform you of a temporary adjustment to the EAF, which will apply for the period 23 June to 30 June 2025.

This exceptional measure is a direct result of the ongoing conflict between Israel and Iran, which has caused a significant and sudden increase in Marine Gas Oil (MGO) prices across the global market. Given the scale and unpredictability of this event, it qualifies as force majeure.

We understand that any surcharge affects your business, and we want to assure you that this adjustment is being made with careful consideration. While a **temporary ceasefire** has recently been announced, the underlying situation remains uncertain, and oil markets continue to be volatile. For now, the surcharge will remain in place, but in response to this evolving context, **we will move from our usual monthly review to a weekly evaluation of EAF levels**, adjusting them as needed based on market developments and fuel pricing trends.

For the period 23 June to 30 June, the following EAF surcharge levels per trade and bound are applicable.
